

Announcement of Election

Election of student representatives (Fachschaftsvertretung) for the Fachschaften Rechtswissenschaften und Volkswirtschaftslehre

The student representatives (**Fachschaftsvertretung**) for the **Fachschaften Rechtswissenschaften und Volkswirtschaftslehre** of the university of Bonn will be elected.

19 representatives will be elected in the Fachschaftsvertretung Jura.

15 representatives will be elected in the Fachschaftsvertretung Volkswirtschaftslehre.

The election will take place from 2024-05-13 to 2024-05-15.

Candidacies

If you want to use a sample please contact the election supervisor. The use of the sample is recommended.

Candidacies must be handed to the election supervisor (wahlausschuss@fsjurabonn.de) until **2024-05-02 at 23:59**.

The candidacy must at least contain the following aspects: name, surname, how the name should be written on the ballot, address, email address, matriculation number, the title of the election, and a signature.

The candidacy must be written in German.

Voting system

The Fachschaft forms a constituency. Everybody who is eligible to vote can vote for one candidate.

The people with the most votes and at least one vote are elected.

If two candidates got the same amount of votes the election supervisor will decide the order by lot.

If an elected person resigns the seat will be filled with the person that got the most votes and at least one and is not a member of the representatives yet. If every elected person is a member of the representatives the seat will not be filled again.

If at one point more than half of the seats are unoccupied new elections will be held as soon as possible. The chairperson of the FSR immediately summons a meeting of the FSVV which decides on a new date and a new election committee.

Electoral register

Every member of the Fachschaft Rechtswissenschaften at the university of Bonn by **2024-04-13** is eligible to vote and to be elected. If you are a member of multiple student bodies, you are only eligible to vote for a single one.

Everyone who is listed in the electoral register is eligible to vote.

The electoral register can be consulted at the following times and places:

The electoral register can be consulted from **2024-04-24 to 2024-04-26** in the office of **Fachschaft Jura (Lennéstr. 31) from 12:00 to 13:00 o'clock.**

Objections to the accuracy of the electoral register can be raised during the time listed above, but no later than the **2024-05-02 at 23:59**. They need to be submitted to the election supervisor.

Vote by Mail

In exceptional cases a reasoned request for vote by mail can be submitted. The request must be justified and handed in in written form. It must include your name, address and matriculation number. Requests for vote by mail must be handed in until **2024-05-02 at 23:59**. The request must be submitted to the election supervisor. Every postal voter needs to get his postal voting documents until 24hours before the election from the election supervisor. Postal voters who can't get their documents in person can request to get them send.

Counting

The public counting will take place on the 2024-05-15 at 18:30 in the Office of Fachschaft Jura.
